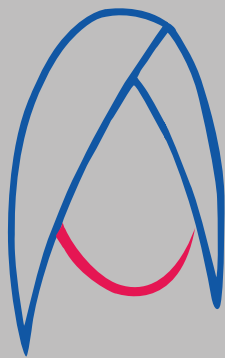

## Executive Summary

The Awareness of Women and her Advocacy with Zeal – AWAZ project is 01 year long intervention of Peace by Youth (PY) for women issues related project, funded by USAID Small Grants and Ambassador's Fund Program started from November 15, 2014 to October 31, 2015 with objective of establishing Legal Information Centers (LIC) at District Civil and Session Courts of district Jacobabad for providing free legal aid and advice to every court visiting women.

With a Human Development Index (HDI) of 0.523 as compared to the provincial average of 0.628, Jacobabad is one of Sindh's lesser developed districts, where poverty, non-availability of health & educational facilities, and lack of livelihood opportunities are at a high level. Another indicator of the district's dismal state of affairs is the status of women residing thereat.

By and large women in the district not only possess little awareness about their legal rights and entitlements but are also deprived of the most fundamental entitlements. Disallowed education, deprived opportunities of seeking quality health care, denied inheritance, forbidden to take critical decisions about their life, and subjected to abuse and violence in one form or the other, women of the area are treated as second rate citizens.

Cognizant of the fact that any improvement in women's status will begin with first ensuring that their rights are acknowledged, respected and secured, PY implemented Awareness of Women and her Advocacy with Zeal – AWAZ project, a 11 months long intervention in district Jacobabad with support of Small Grants and Ambassador's Fund Program (SGAFP) with providing free legal advice and guidance to vulnerable women of district Jacobabad, and initiated a shift in the perception and behavior of the masses towards women rights through AWAZ Awareness and Publicity campaign.

Establishment of Legal Information Centers (LICs) in court buildings was a tough task and immense efforts were put in to establish the LICs in both courts. The elections of District Bar Association (DBA) caused limitations in achieving the required target of establishing Legal Information Centers (LICs) at court premises. Therefore it took almost 5 months to allow the centers in court buildings, so the LICs have started their work from May 2015.

Soon after establishing Legal Information Centers (LICs) at end of May, 2015, women started visiting us and take guidance for their legal matters. Our highly trained and well qualified team of advocates started to provide their services at court time. 247 women visited both LICs and took the legal guidance. There are a number of success stories which show the immense efforts of project team to facilitate every visiting women.

## Introduction

With a Human Development Index (HDI) of 0.523 as compared to the provincial average of 0.628, Jacobabad is one of Sindh's lesser developed districts, where poverty, non-availability of health & educational facilities, and lack of livelihood opportunities are at a high level. Another indicator of the district's dismal state of affairs is the status of women residing thereat.

By and large women in the district not only possess little awareness about their legal rights and entitlements but are also deprived of the most fundamental entitlements. Disallowed education, deprived opportunities of seeking quality health care, denied inheritance, forbidden to take critical decisions about their life, and subjected to abuse and violence in one form or the other, women of the area are treated as second rate citizens.

## Objective of the project

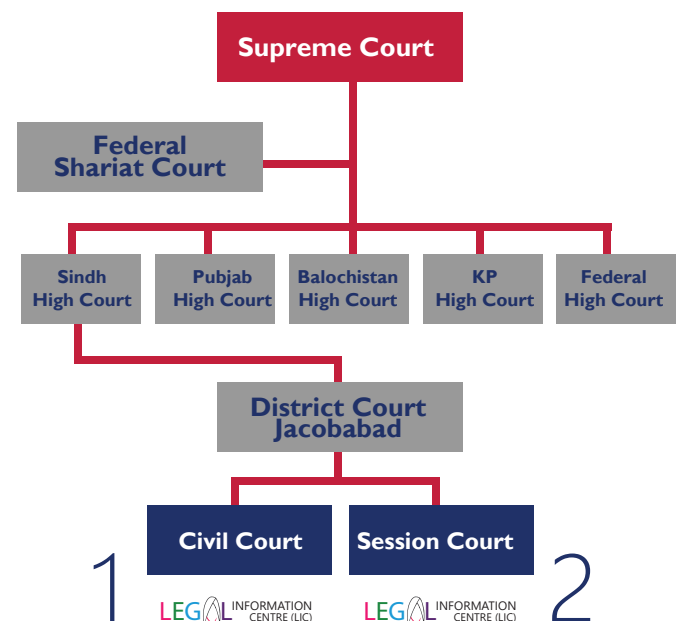
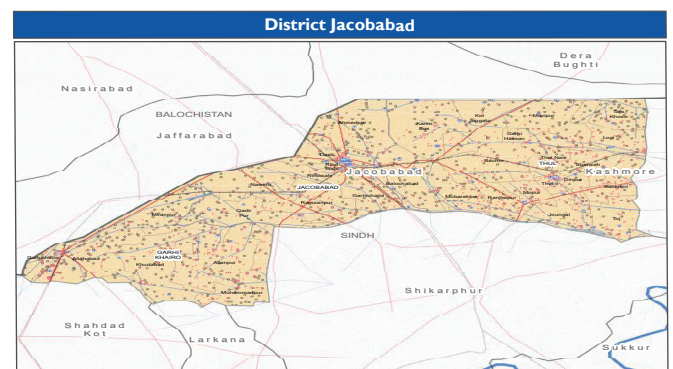
The objective of the AWAZ project was ensuring that women's rights are recognized and secured by:

- Establishing Legal Information Centres (LICs), one each in Civil & Session Court of the district, for provision of free legal guidance to women; and
- Carrying out an Awareness & Publicity Campaign focusing on women rights.



## Project Location

The AWAZ project has been implemented in the district Jacobabad. Legal Information Center (LIC) been established in District Civil & Session Courts of Jacobabad district.



## Project Accomplishments

Peace by Youth (PY) has achieved the following results by engaging 08 team members for implementing Awareness of Women and her Advocacy with Zeal - AWAZ project;

- Establishment of (2) two Legal Information Centers (LIC) each one in Civil & Session court premises of district Jacobabad.
- LICs set up in a room especially allocated by concerned courts and manned with 02 female lawyers, providing following services free of cost to all visiting women;
  - Legal information;
  - Case related guidance; and
  - Referencing to relevant lawyers
- PY launched an Awareness and Publicity campaign during the course of the project
- The campaign comprised one hour long Talk Shows & 30-seconds long Public Service Messages aired on HOT FM 98 Jacobabad for three months.
- The talk shows & public service messages primarily focused on the following topics;
  - Domestic Violence;
  - Dissolution of Marriage;
  - Muslim Family Law;
  - Guardian and Ward Act;
  - Law of Inheritance;
  - Transfer & Property Act;
  - Honor Killing;
  - Mental/Physical Torture;
  - Sexual Harassment; and
  - Criminal Law.
- PY engaged the local women activists, religious, political, and social leaders from local community of district Jacobabad during the Awareness & Publicity campaign by inviting them for talk shows. PY also engaged women lawyers & District Bar Association (DBA) Jacobabad lawyers for advocacy and awareness campaign.

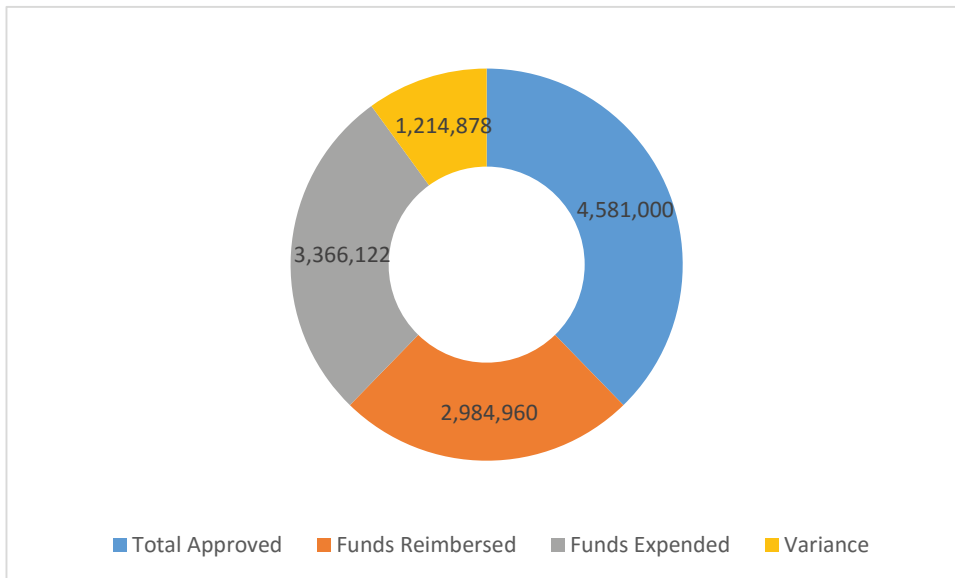
## Awareness & Publicity Campaign

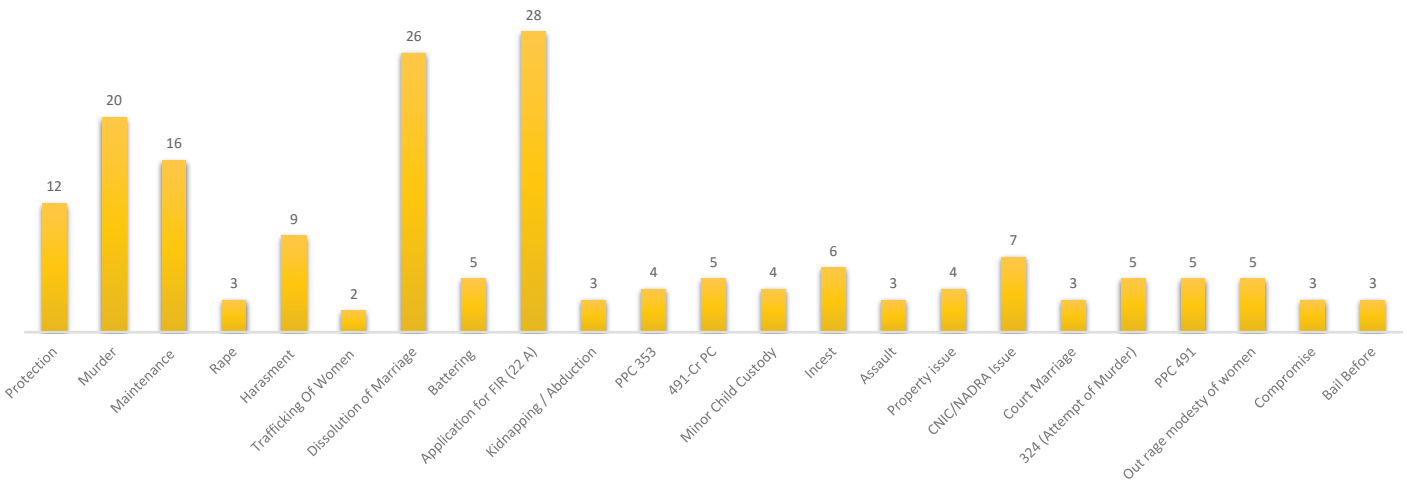

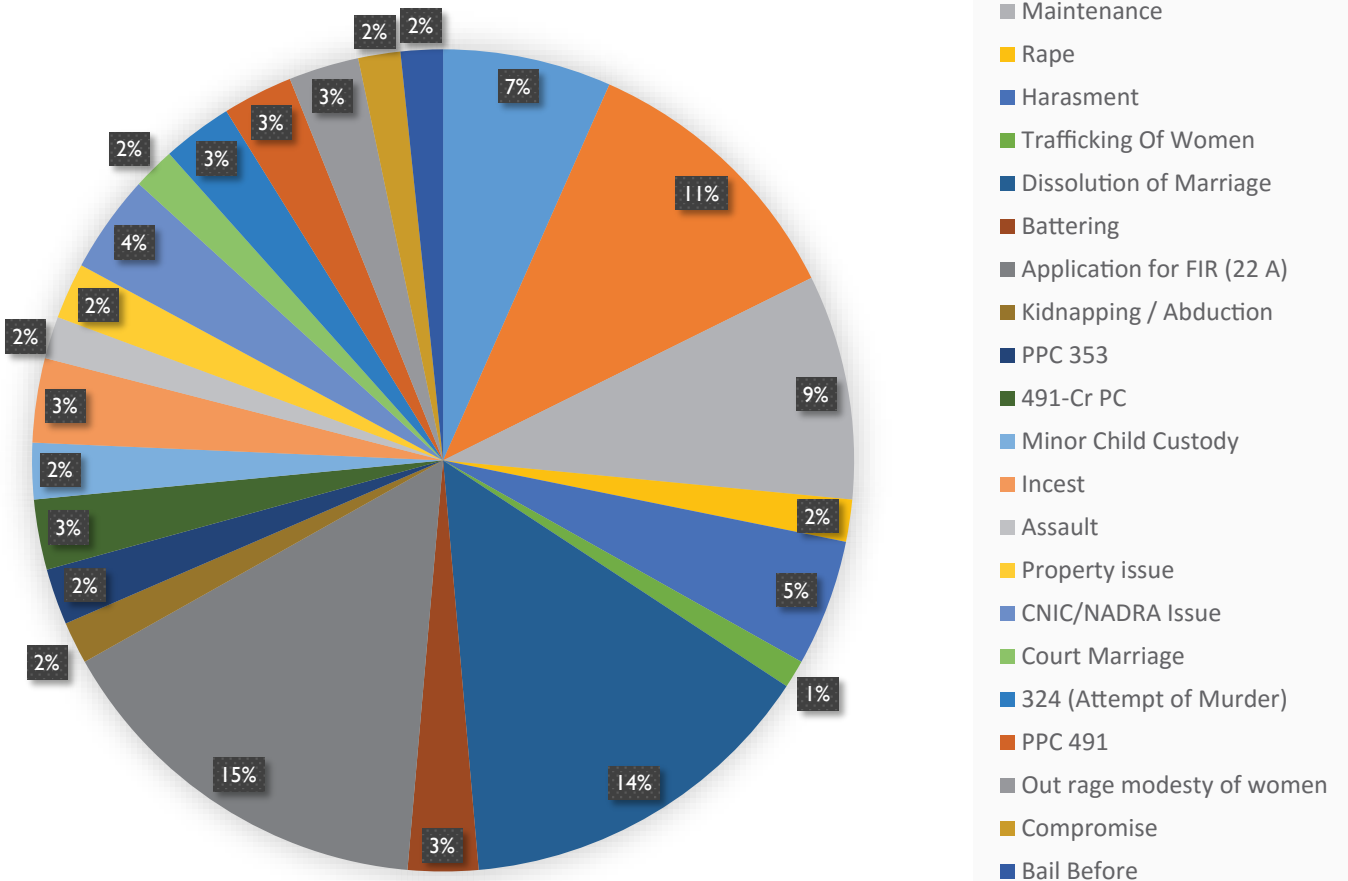

## Success Stories

## Success Story - I

### Back to home with Pride, Honor and Peace.

“You have showed me the way, if I would not have found your services abruptly, today I would not have alive here before, this all are the efforts of LIC staff to guide me and motivated my parents and family members to reach on a peaceful settlement.”

### Background of Beneficiary & Issues;

A young girl (24 years) Allah Wasai residence of village Mirpur Buriro abducted by a man from her house and reached at session court to get marriage but spontaneously man faded away when they reached near court man fled away and girl felt insecure herself and reached at legal information center and informed all story from abducting her house and cheating from her lover one she also told that if she will back her home then her parents would give her the title of Kari and she will be get sentence of murder,

It was a serious issue the life of a young innocent girl, the decision of her family was totally would affect her life.

### Actions taken by LIC:

When Allah Wasai felt insecure herself at the lawn of session court she was alone there, she was told by the staff of court to stay at LIC and necessary guide line, then abruptly she came to LIC and told all her story then the present staff at LIC. And besought to save her life from her family and relatives.

Then the present staff of LIC asked necessary questions and took information and presented her before the magistrate for statement and security, magistrate ordered to police to take her in its custody, later on Allah Wasai was given to the custody of ladies police and she was sent to Darul-aman Larkana.

After two days the parents of Allah Wasai reached at LIC and asked to resolve their issue peacefully, then the LIC staff gave the application to police to resolve the issue. Police brought the girl back from Darul-Aman Larkana, and again she was presented before magistrate along with her parents and relatives, the magistrate asked the willing of girl to live with?

Girl showed her willingness to go with their parents if they would give the surety of her life, the LIC staff counselling her parents no to hurt her girl and forgave for her act to abduct from her house, the parents were mobilized not to hurt her daughter if she would come with them, then the LIC staff took efforts to motivate and satisfied the police and magistrate to take an statement of girl's parents then magistrate asked her parents to give the security to her daughter, the parents agreed, thus the magistrate ordered to release the girl and she went with her parents peacefully to her home.

### Actions changed life of Allah Wasai

The action of LIC made the easy to take decision and provided the safety and security to the beneficiary thus, the life of an innocent girl saved and she went peacefully with her parents and a family secured itself from a crime. It effected directly on the life of two lives.

### The action motivated community as whole

The LIC staff took efforts to save the life of an innocent girl and motivated the community no to hurt the girl, thus the family and parents of girl motivated and agreed not to murder her girl and a mean custom of karo kari was rejected and peacefully settled the dispute/ issue.

### Start a new life without tension.

the LIC staff has given such a way and guidance to live and start a new life, it's a gift for me to go with my husband to forget my all previous hard life.”

#### **Background of Beneficiary & Issues;**

Mrs. Reshma from Bagri community was got married in her early age, and thus her rainy days started she suffered very hard ships in her early life and sicked off form her life, her husband has died when only her marriage has passed two years and according to bagri community's traditions she was ignored from all rights she was only performed her role as servant at the same home, and always she was get sentenced to make the responsible of the death of her husband.

Reshma left her home and got married with a muslim young Liaquat Hussain Residence of Quetta Balochistan, and started a new life with a new family and changed her religion with her willingness without any pressure or black mailing.

The relatives of Reshma teased and developed pressure on her to back her in bagri community at same home, Reshma along with her husband reached at Session Court Jacobabad, the staff of court guided and suggested for LIC for further legal assistance and guidance to make secure from her community.

#### **Actions taken by LIC:**

The beneficiary reached at LIC and then the present staff at LIC got necessary information and asked some questions according to legal requirements, and took action to forward the case to the, “ Human Rights batch chapter Jacobabad, for further legal support and aid.”

#### **Actions changed life of Allah Wasai**

The Human rights groups registered the case and presented the beneficiary before session judge for statement, the court took the decision that, Mrs. Reshma the new name Shahida will be independent in her decision whether she will go with husband or parents,

Mrs. Shahida gave her statement to go with her husband and she had no any pressure or any kind of repent, then the honorable court ordered to go with her husband Mr. Liaquat Hussain, thus the issue was resolved peacefully.

#### **The action motivated community as whole**

The community was motivated for the independent decision of a girl and peaceful settlement with the efforts of LIC.
